STRANDS

Strand 1: Intercultural and Multicultural Education: theoretical underpinnings and research priorities

This strand focuses on theoretical perspectives and conceptualizations of intercultural and multicultural education and explores possibilities to both broaden and deepen our understandings of, and views of, identity and diversity issues. Researchers will present their papers that situate intercultural and multicultural education policies and practices within multiple layers of global-local contexts whereby discursive practices regarding multicultural and intercultural education are both elaborated and constrained. By constructively challenging and providing new insights into evolving epistemic models for multicultural and intercultural education, this strand hopes to contribute to international collaborative efforts to open up new possibilities for intercultural/multicultural education.

Strand 2: Inclusive Education and the diversity spectrum

Nowadays, more than ever, Inclusive Education is in priority aiming to give space to all diverse groups. In priority for the specific Conference, culturally diverse students and their families as well as culturally diverse students with special needs. Emphasis is given on human rights education for all diverse students.

Strand 3: Dimensions of diversity: Educational opportunities and challenges connected to human rights

This strand can be characterized as being focused on 'diversity among the many diversities that characterize contemporary society', how these diversities connect to human rights issues and the resulting consequences for education. The human rights dimension of the strand focuses both on individual and community rights, as well as educational responses to human rights violations. The strand will showcase the many intersectionalities that define today's multicultural societies. Presentations will include both individual presentations and panel discussions.

Strand 4: Migrant and Refugee Education

Strand Chairs: Eleni Oikonomidou, Fred Carlo Andersen and Tomislav Tudjman

Co-chairs: Domna Michail and Kostas Magos

This strand focuses on both education *about* migration *and* migrants, and education *for* migrants in the reception countries. We invite papers that focus on the educational backgrounds of migrants before migrating to a new country, their access and adjustment to the educational demands in the receiving country, their educational achievement over time compared to their country counterparts, and the value that education plays in their future endeavors. Of particular importance is how migrants are integrated (integration seen as a two-way process) into schools, the language expectations they must meet, the curriculum they are exposed to, the support they receive from teachers and their parents, the peer networks they develop, and the educational attainment they achieve. This strand also invites papers that explore approaches, good practices, formal education or non-formal education (civil society) projects that seek to sensitize mainstream population about migration, integration of migrants into receiving countries, dangers of xenophobia and its various facets.

Strand 5: ICTs, Online learning and vulnerable groups in Covid-19 Pandemic

Strand Chair (from IAIE): Miri Shonfeld and Hasan Aydin

Co-chairs: Tami Seifert, Frederik Smets and Emmanuel Fokidis

Sessions in this strand will introduce innovative, new methodologies in ICTs and online learning for vulnerable groups. The COVID Pandemic has exacerbated the challenges that exist globally to keep students in school and to help them meet their full potential. The gap that already existed between the 'haves' and 'have nots', and the early school leaving rates among underserved communities, has widened. This strand addresses these and related issues.
